



EAU-COIN WEBSITE TERMS AND CONDITIONS

1. Introduction.

These Website Standard Terms And Conditions (these “Terms” or these “Website Standard Terms And Conditions”) contained herein these webpages, shall govern the user (hereinafter referred to as “the viewer”) making use of this website, including all pages within this website (collectively referred to herein below as this “Website”). These Terms apply in full force and effect to viewing, use and interaction to, on and via this Website; and by using this Website, you the viewer expressly accept all terms and conditions contained herein in full. You must not use this Website, if you have any objection to any of these Website Standard Terms And Conditions.

This Website is not for use by any minors (defined as those who are not at least 18 years of age), and you must not use this Website if you a minor.

2. Intellectual Property Rights

Under these Terms EAU-COIN.COM, the EAU-COIN BRAND, its OWNERS and/or its licensors (herein after collectively called “EAU-COIN”) own all rights to the intellectual property and material herein and these restrictions of rights apply to any one and all viewers merely view and/or who become purchasers from, by or because of the content in this Website for which all rights are fully owned and/or copyright reserved in the sole name of the EAU-COIN brand. This applies in particular to all logos, emblems, coin pictures, text, layouts, catch-phrases, particular descriptions, definitions and very specially to the EAU-COIN business model itself.

3. Ownership of Tokens.

When token purchases are completed successfully, a transfer of ownership of those tokens will occur from the EAU-COIN brand to the viewer who then becomes a buyer and a viewer, who buys those tokens successfully purchased, and then is defined herein as the owner, but not before the moment that they are paid for with clean, clear and compliant funds of either:

1. Another acceptable crypto currency and/or multiple crypto currencies, the token(s) of which is/are accepted by EAU-COIN brand at their sole and final discretion, or:-
2. Cash FIAT (paper) money, the type(s) of which currency is/ are accepted by EAU-COIN brand at their sole and final discretion.

3. Continued:-

Subsequently, at the time of redemption of tokens at any and all cash-outs and/or roll-overs of tokens, all external token holders of tokens who are not the EAU-COIN brand who originally purchased their tokens through the website and/or by private treaty with EAU-COIN successfully accomplished previously, or hold legitimate tokens gotten by use inside the ecosystem of the EAU-COIN brand by lawful transaction process that were originally issued by the EAU-COIN brand, may be redeemed at their original purchase price plus bonus as applicable at the time of purchase, or rolled over into other ROUND issues of tokens at their original purchase price with their bonuses according to the rules of token issue acquisition and redemption prevailing at those times, and offers available in new ROUNDS.
